Each National Small Business Person of the Year is selected by the SBA Administrator based on the recommendations of the Agency's National Small Business Week panel of judges. The winner is announced during National Small Business Week.

Small Business Person of the Year winners from each of the 50 states will converge on Washington, D.C. in May, when one of them will be selected as National Small Business Person of the Year during the SBA's celebration of National Small Business Week, May 20-22. While in D.C., the winners will have opportunities to meet with top administration officials, congressional representatives and national business leaders. The highlight of the celebration will come when one of them is named National Small Business Person of the Year.

Adrian Woolcock's nomination was recommended by Theron Simpson, Jr. (Executive Vice President and Certified Mentor) of The Charlotte Chapter of The SCORE Association (previously known as the Service Corps of Retired Executives). Now recognized as SCORE, "Counselors to America's Small Business.", this 501(c)(3) nonprofit organization provides business mentoring services to entrepreneurs in the United States by both active and retired business executives. SCORE is a resource partner of the U.S. Small Business Administration and is supported by a network of 12,000+ volunteers.

Each state's Small Business Person of the year must meet criteria which include staying power, growth in employment, increase in sales/unit volume, innovation, response to adversity, and evidence of contributions to his/her community. The Small Business Person Of The Year award is granted to any individual (or partners) who owns and operates or who bears principal responsibility for operating a small business and meet and exceed the following criteria:



- 1. Staying Power a substantiated history as an established business
- 2. Growth in number of employees a benchmark to judge the impact of the business on the job market
- 3. Increase in sales and/or unit volume an indication of continued growth over the last three years.
- 4. Current and past financial performance financial reports substantiate an improved financial position of the business.
- 5. Innovativeness of product or service offered an illustration of the creativity and imagination of the nominee.
- 6. Response to adversity examples of problems faced in the nominee's business and the methods used to solve them
- 7. Contributions to community-oriented projects evidence of the use of his/her personal time and resources

This is the highest honor bestowed by SBA each year in celebration of the outstanding achievements, challenges and contributions of our small businesses. As a nominee for the Small Business Person of the Year, Adrian Woolcock is being recognized for developing an outstanding, growing business; excellence in client services(s), increasing jobs, increasing sales, overcoming adversity, while also contributing to the community.
